Luckenback is a tiny town "Deep in the Heart of Texas." It is 50 miles north of San Antonio and 50 miles west of Austin, by the banks of the Pedernales River, and had a peak population of 492 in 1904 per Wikipedia, the free on-line encyclopedia. Responding to an ad in the paper that read "Town - population 3 - for sale," a rancher named Hondo Crouch purchased Luckenback for the sum of \$30,000 in 1970. Hondo turned the town's dance hall into a country music Mecca for musicians and fans alike. (How do you have a dance with three people? Excuse me, Are you with him? May I cut in?)

I've never been to Luckenback and must have blinked when I drove past on my post-Bar Exam cross country trip back in '91. It was my turn to drive during that particular stretch of the trip that traversed the landscape of central and west Texas. Rolling hills, no trees, pick-up trucks and oil derricks for 600

miles from Dallas, past Buddy Holly's hometown of Lubbock, all to get to "Amarillo by Morning." So, I don't know exactly what Willie and Waylon are talking about, but I guess the song is just a metaphor for



kicking back and a suggestion to "Take it Easy." Sort of a polar opposite to the Eagles song, "Life in the Fast Lane," with the refrain of "everything, all the time." Practice Notes...

Family law - alimony - post-separation cohabitation: 1) Trial judge erred by refusing to consider post-separation "marriage-type relationship" by wife with third person as part of her "financial status" and "standard of living" factors. 2) There was insufficient evidence to permit a survivor benefits award when no evidence showed the value or cost of this. *Whittington v. Whittington*, — Md. App. — (1/4/07).

Family law - grandparents revisited: The Court of Appeals upholds grandparent visitation statute (FL 9-102), but implies additional requirement, as in 3rd party custody cases, that a) parents must be "unfit" or b) "extraordinary circumstances" must be found before trial court can override parents' presumptively appropriate decisions as to grandparent access. *Koshko v. Haining*, — Md. — (1/12/07).

Family law - Soldiers' & Sailors' Relief update: The current federal statute as to active military members (50 App.U.S.C.A. §§ 522(b)(2)(A, B)) provides that a civil court automatically must

grant at least a 90 day stay if member files appropriate motion with letter from commanding officer stating that military obligations prevent leave to attend court. Motion for further discretionary stay may be made on similar grounds. *Hernandez v. Hernandez*, 169 Md. App. 679 (2006).

Contracts - obligation to apply for financing: Where contract did not otherwise specify, a party complied with condition to seek financing by making a single application. *Meyers v. Kahoe*, 391 Md. 188 (2006).

Civil procedure - limitations: 1) Administrative order must be appealed within 30 days from filing, not receipt. *Centre Ins. v. JTW*, — Md. — (1/9/07). 2) Limitations for employee discharge claim began with date of discharge, not letter confirming it. *Haas v. Lockheed Martin*, — Md. — (1/9/07).

Criminal evidence - defendant's testimony in unrelated case: If defendant in upcoming criminal case testifies for co-defendant, State's use of cross-examination depends on: 1) limitation of cross to scope of direct and "matters affecting credibility," rather than becoming discovery deposition; and 2) entire testimony must be prefaced by Miranda-type warning. *Rollins v. State*, — Md. App. — (12/13/06).

When you have a conflict in your schedule

Nancy Baker, Circuit Court Postponement Coordinator

Editor's Note: This is the second in a series of articles about Anne Arundel County courthouse employees. The information provided herein is not intended to be legal advice.

It happens to everyone at one time or another: the court sets a hearing date that conflicts with another one of your cases or your vacation plans. Perhaps your client is scheduled to have surgery on the date of the hearing. As the Anne Arundel County Circuit Court Postponement Coordinator, Nancy Baker deals with these issues, along with requests to appear via phone, on a daily basis.

Baker is part of Administrative Judge Manck's support staff and can be found on the fourth floor of the Circuit Court in Judge Manck's chambers. She processes civil, family, and criminal case postponement requests by making sure the motions

have all the necessary information before being sent to Judge Manck for a ruling. She took over the job approximately a year ago from the former coordinator Stephanie Montgomery, who is now Judge Mulford's administrative assistant.

Baker, however, is no stranger to the courthouse. She worked in the Court Clerk's department for 19 years. For 14 of those years, she served as the Assistant Supervisor of the courtroom clerks. Baker described the transition from courtroom clerk to postponement coordinator as being fairly easy. Although she misses being in the courtroom during the more interesting criminal trials, she likes dealing with all of the judges as the postponement coordinator.

The most common reasons for the postponement request tend to be trial conflicts or vacation conflicts. Beware though: if you are seeking to move a hearing date that you and the opposing counsel previously agreed upon, you must have a compelling reason to request the postponement. Once the motion has been ruled upon, Baker typically makes a courtesy call to the attorneys to let them know of the outcome.

For those with out-of-town clients, you can file a request to appear via phone for the more administrative hearings, such as scheduling conferences. The request must be in motion form. If granted, Baker provides information about Court Call. The party also can provide a number at which they can be reached at the appropriate time.

When she is not at work, Baker enjoys time with her three teenage children, husband, and dog at their home on the Eastern Shore. ■

The Perfect Postponement Request

- 1) Clear a new date with the Assignment Office and opposing counsel. This "tentative reset date" should be noted in the motion.
- 2) Make your request in motion form.
- 3) Include whether or not the opposing counsel/party objects to the postponement request and whether the tentative reset date has been cleared with them.
- 4) Provide a proposed order with the tentative reset date.
- 5) Contact Ms. Baker to let her know of the filing or if you are walking it through chambers, especially if filing at the last minute or the day of the hearing.

In memoriam

Bennett Crain, Jr.: 'A southern gentleman of impeccable character'

With the passing of Bennett Crain, Jr., on Sept. 3, 2006, the bar association has lost the epitome of the respected country lawyer.

Born Oct. 1, 1930, Bennett grew up on his family's farm in Charles County. He learned of law and politics from his lawyer father and of hard work from the chores of the farm during wartime. At Episcopal High School and the University of Virginia his southern attributes were molded into a classic, fun loving, southern gentleman of impeccable character and integrity. He was at the same time a fighter for his principles and caring for and gentle with his family, friends and associates.

His grandfather, Robert Crain, was a prominent Maryland legislator, who succeeded in having Route 301 connect the rest of the world to Southern Maryland. It and other Crain Highways were named in his honor, including the one in Glen Burnie.

After graduating from University of Maryland Law School, Bennett joined the Army Judge Advocate Corps for three years as a trial lawyer. After his release from the army he set up practice in Annapolis with Barham Gary on State Circle. Upon Gary's death in 1965, Bennett joined forces with the law firm of Fell and Hartman on Duke of Gloucester Street under the name of Hartman and Crain. His practice flourished until his retirement in 1993.

During his tenure in Annapolis, Bennett served as reporter for the Charter Board and worked tirelessly for adoption of the charter form of county government. Upon adoption of the charter in 1964, Bennett became County Solicitor under Joe Alton, but continued his ties with Hartman and Crain.

Bennett was president of the Southern Maryland Society, a member of the Annapolis Yacht Club, the Sailing Club of the Chesapeake and the Chesapeake Bay Yacht Racing Association. He was a part owner of, and active in, management of the Annapolis boat shows. Despite all of his activities and associations, he was able to cruise to the end extensively on his 41 foot sailboat, Landsend, on the Chesapeake and throughout the Bahamas and Caribbean Sea.

Bennett is sorely missed by his family and all who knew him. ■
